CORKAGE BAR SERVICE GUIDELINES

- CORKAGE BAR SERVICES CONTRACTED THROUGH THE CALGARY WINTER CLUB MUST BE ACCOMPANIED BY THE ALCB PERMIT WITH ALL RECEIPTS (OR RECEIPT COPIES) OF THE AMOUNTS DELIVERED TO THE CWC. THE CORKAGE BAR WILL BE CLOSED AT 12:30 AM AND THE GUEST WILL HAVE ONE HOUR AFTER THAT TIME TO CONSUME THEIR DRINK.
- DELIVERIES MUST BE ARRANGED DURING NORMAL BUSINESS HOURS, AND SHOULD BE DELIVERED TO THE CWC SHIPPING / RECEIVING DOCK LOCATED OFF 14TH STREET NW BETWEEN 8:00 AM - 12 NOON AND 1:00 PM - 4:00 PM, MONDAY THRU FRIDAY ONLY.
- DUE TO ALBERTA GAMING & LIQUOR REGULATIONS, ALL ALCOHOLIC BEVERAGES MUST BE SUPPLIED BY A LICENSED VENDOR IN THE PROVINCE OF ALBERTA. THE USE OF HOMEMADE WINES OR SPIRITS FROM OTHER COUNTRIES OR PROVINCES IS PROHIBITED BY LAW. FOR ANY FURTHER DEFINITION, PLEASE CONTACT THE CALGARY WINTER CLUB / FOOD & BEVERAGE OFFICES.
- SERVICE OF ALL ALCOHOLIC BEVERAGES MUST BE IN ACCORDANCE TO ALBERTA GAMING & LIQUOR COMMISSION REGULATIONS AS THEY ARE OUTLINED FOR SPECIAL EVENT PERMITS.
- THE CORKAGE BAR SERVICE DOES NOT ALLOW FOR A COMBINATION OF PERMITS TO RUN BETWEEN THE CALGARY WINTER CLUB AND THE PATRON'S PERMIT. DUE TO REGULATIONS ONLY ONE PERMIT AT ONE TIME CAN BE VALID IN A SIMILAR TIME PERIOD.
- CWC PERSONNEL WILL ENDEAVOR TO MINIMIZE THE OPENING OF PRODUCTS REQUIRED FOR THE EVENT FOR THE PURPOSE OF RETURNING UNUSED PRODUCT. THIS IS ALL BASED UPON THE PARAMETERS DEFINED IN THE PROVISION OF SERVICES OUTLINED IN THE CONTRACT.
- THE PATRON IS RESPONSIBLE FOR THE REMOVAL OF ALL PERMITTED PRODUCTS AT THE CONCLUSION OF THE EVENT. OPEN BOTTLES SPIRITS / LIQUOR CAN NOT BE TRANSPORTED AND THEREFORE WILL REMAIN AT THE CLUB. SHOULD PRIOR ARRANGEMENTS NOT BE MADE WITH THE CWC, ALL PRODUCTS MUST THEN BE REMOVED AFTER THE EVENT. THE CALGARY WINTER CLUB DOES NOT ACCEPT RESPONSIBILITY FOR PRODUCTS STORED AT THE CLUB AFTER THE EVENT. A \$75.00 HANDLING FEE WILL APPLY FOR STORING LEFTOVER ALCOHOL OVERNIGHT.
- THE CALGARY WINTER CLUB FACILITIES ARE CONTRACTED UNTIL 1:30 AM ONLY, AND PATRONS ARE REQUESTED TO MANAGE THEIR SPECIAL ALCB PERMIT TIME PARAMETERS IN ACCORDANCE TO THIS GUIDELINE. SPECIAL REQUESTS BASED UPON SPECIAL HOLIDAYS OR OTHER FACTORS WILL BE CONSIDERED, BUT MUST BE ARRANGED IN THE CONTRACT DEFINITION.
- THE SERVICE OF ALCOHOLIC BEVERAGES TO MINORS (UNDER 18 YEARS OF AGE) IS STRICTLY PROHIBITED; THE CWC WILL MONITOR THIS THROUGHOUT ALL CATERED EVENTS, WITH SERVICE REFUSED SHOULD PATRONS NOT HAVE SUITABLE IDENTIFICATION REQUIRED AND DEFINED BY THE ALCG REGULATIONS.
- PATRONS ARE REMINDED THAT ALCOHOLIC BEVERAGES ARE RESTRICTED TO THE CONTRACT DEFINED AREAS OF THE CLUB, WITH CONTROL OF THIS MANAGED BY CWC SECURITY & CATERING PERSONNEL.

CORKAGE BAR SERVICE GUIDELINES CONTINUED

- DELIVERY OF ALCOHOLIC BEVERAGES FOR CORKAGE BAR SERVICE MUST BE RECEIVED 24 HOURS PRIOR TO YOUR EVENT TIME.
- THIS ENABLES THE CLUB TO INVENTORY, CHILL AND ORGANIZE THE PRODUCTS FOR USE FOR YOUR EVENT. PLEASE INCLUDE YOUR PERMIT AND RECEIPTS (OR A COPY OF THE RECEIPTS) WITH THE DELIVERY FOR ACCOUNTABILITY.
- AN ADDITIONAL SERVICE FEE OF \$100.00 HANDLING WILL BE LEVIED SHOULD DELIVERY NOT BE PROPERLY ORGANIZED.
- THE CALGARY WINTER CLUB PROVIDES A RESPONSIBLE ALCOHOL MANAGEMENT PROGRAM IN AN EFFORT TO ENSURE THE SAFETY OF OUR PATRONS. UNDER THIS PROGRAM, ALL LIABILITY IS JOINTLY THE RESPONSIBILITY OF THE CONTRACTED CLIENT AND THE CWC FOR THE DEFINED TIME PARAMETERS NOTED ON THE EVENT CONTRACT. THIS PROGRAM ALSO ALLOWS ALL EMPLOYEES OF THE CALGARY WINTER CLUB TO MONITOR AND CONTROL THE SERVICE OF ALCOHOLIC BEVERAGES IN A SAFE AND RESPONSIBLE MANNER. ANY ALCOHOL RELATED INCIDENT ARISING DURING AN EVENT REQUIRES THE PATRON AND THE CWC, TO BE JOINTLY RESPONSIBLE FOR A POSITIVE OUTCOME RELATED TO THE INCIDENT
